


**JUDGMENT ON RULE FOR CONTEMPT**

This matter came for hearing on September 26, 2011, on the motion for rule for contempt filed by the Louisiana Manufactured Housing Commission against Pat Townsend, a/k/a Pat Townzen, d/b/a Affordable Mobile Home Movers. Present in Court were Stephen A. Quidd and Erin E. St. Pierre, attorneys for the Louisiana Manufactured Housing Commission, and Pat Townsend, a/k/a Pat Townzen, d/b/a Affordable Mobile Home Movers, in proper person

The Court considering the law and evidence to be in favor of the Louisiana Manufactured Housing Commission, and against Pat Townsend, a/k/a Pat Townzen, d/b/a Affordable Mobile Home Movers, for the oral reason assigned:

IT IS ORDERED, ADJUDGED AND DECREED that three counts of contempt for violating the preliminary injunction signed July 22, 2010 be sustained against Pat Townsend, a/k/a Pat Townzen, d/b/a Affordable Mobile Home Movers, and that Pat Townsend, a/k/a Pat Townzen, d/b/a Affordable Mobile Home Movers be sentenced as follows:

1. That Pat Townsend, a/k/a Pat Townzen, d/b/a Affordable Mobile Home Movers be sentenced to four (4) months imprisonment for each count of contempt to be served consecutively for a total of twelve (12) months;
2. That the sentence of imprisonment set forth be suspended, and that Pat Townsend, a/k/a Pat Townzen, d/b/a Affordable Mobile Home Movers be placed on a twelve month active probation with the following terms and conditions:
  - a. That Pat Townsend, a/k/a Pat Townzen, d/b/a Affordable Mobile Home Movers be sentenced to serve twenty (20) days for each count with the twenty (20) days to be served concurrently for all three counts,
  - b. That said twenty (20) days be served on ten (10) consecutive weekends, commencing on Friday, September 30, 2011, and
  - c. That said service to commence at 7:00 p.m. each Friday and to end at 7:00 p.m. each Sunday.




3. That Pat Townsend, a/k/a Pat Townzen, d/b/a Affordable Mobile Home Movers be ordered to pay a fine of five hundred dollars (\$500.00) concurrently for each count of contempt.
4. That Pat Townsend, a/k/a Pat Townzen, d/b/a Affordable Mobile Home Movers be ordered to pay all court costs related to these proceedings.
5. That Pat Townsend, a/k/a Pat Townzen, d/b/a Affordable Mobile Home Movers be ordered to pay attorney's fees for the Louisiana Manufactured Housing Commission in the amount of five hundred dollars (\$500.00).
6. That Pat Townsend, a/k/a Pat Townzen, d/b/a Affordable Mobile Home Movers be ordered to pay the sum total of the fine, court costs, and attorneys in twelve equal installment to the probation officer, with each payment prorated between the fine, court costs, attorney's fees.
7. If Pat Townsend, a/k/a Pat Townzen violates his probation as set forth above, the suspension of the sentence of imprisonment shall be revoked and original sentence of four (4) months imprisonment for each count of contempt to be served consecutively for a total of twelve (12) months shall be imposed and executed.
