The Office of State Fire Marshal, Louisiana State Uniform Construction Council, hereafter referred to as the "LSUCCC" or the "Council", hereby submits the following summary report, in accordance with La. R.S. 49:968(D)(1)(b), and asserts its intentions to proceed with rule-making procedures by finalizing the Notice of Intent which was published in the August 2020 edition of the Louisiana Register (Vol.46, No. 08). A copy of the Notice of Intent is attached hereto and labeled as Exhibit "A". The deadline to submit comments or request a public hearing was September 9, 2020 at 4:30 p.m. Pursuant to R.S. 49:953(A)(2)(a), there were no comments submitted, nor was there a request for a public hearing. Therefore, a hearing was not held.

Please advise if you have any questions or concerns. Subject to legislative oversight by either committee, the LSUCCC intends to submit a final Rule to the Office of State Register for publication in the November 2020 edition of the *Louisiana Register*.
